CHRIS Updates

- Updates to the CHRIS program were described.
 - Locator Screen tabbing option added
 - Service Coordination event portal sorting fixed so Referral First Contact is always first
 - o DOB was added to display next to "Record Creator" on the top gray line
 - o Increased the font size of all fields in that top gray line so they stand out more
 - o Added Timeline Status to the Record Locator screen
 - Enabled tabbing/select for the Screening and Evaluation screens so that the drop-down lists expand when using the tab key to move from field to field
 - Added a new text field below Directions to home called "Previous Addresses"
 - o Expanded the Address fields in Sig Adults to accommodate longer addresses
 - Record Transfer functionality was added and made available to Data Facilitators
 - Added a confirmation message to the "Add Timeline" option in case a user clicks by accident

COS Form Updates

- COS form for Indicator 7 functionality was added to CHRIS and released statewide July
 - o 158 users have access to the COS process form
 - 64 are existing CHRIS users with COS process form access
 - 94 are users who only have access to the COS process form
- Locator Jr. option was added
- COS Report option was added
- Programming was changed so that COS date is not allowed to be prior to the IEP date

User Requests

- Request Add Allow future dates to be entered in the Parent Consent date field in the IEP/IFSP screen
 - This will not be implemented because future dates should not be entered into CHRIS.

- Request User would like to use a keystroke to fill in the "Lives With" and the "Legal Guardian" options instead of having to click with a mouse
 - o This will be addressed towards end of grant year if funds are available.
- Request Some users are running into the more than 500 records limit in Reporting when they try to run annual reports. Is this a common occurrence?
 - No change at this time. We will include this in the annual CHRIS survey to better gauge the extent that this is an issue for users.
- Request Add another "Language" field to each significant adult
 - Yes, this will be implemented
- Request Have three email fields with corresponding notes fields for each significant adult
 - Add a notes field to the existing significant adult email where additional information could be entered

Other

- Discussion of possible additional functionality or modifications.
 - We will research the possibility of having changes to site-defined lists update immediately rather than overnight
 - No changes will be made in CHRIS at this time
- Discussion of encouraging or requiring entry of Part C children to facilitate transition process and continuity of services if children move.
 - Discussions are happening at DOE
 - No changes will be made in CHRIS at this time
