




New Master Database! Aimee A. Echeverri



he CHRIS Statewide Master Database is officially here! We are excited to annouce that all 36 Florida Diagnostic and Learning Resource System (FDLRS) sites have been converted to the latest version of our program, Citrix CHRIS Plus. The process of converting site data began earlier this year in March and ended in October. The conversion process consisted of: 1) installing and setting up the Citrix client software on each computer that would be accessing CHRIS, 2) merging all site data into one large database, and 3) conducting online training for data facilitators and users on how to utilize new functions in CHRIS.



Localized Maintanance

Citrix CHRIS *Plus* enables the Help Desk to centrally manage site data and server operations. As such, data facilitators can now focus on more important issues like the quality and quantity of their CHRIS data. The Help Desk will now oversee the following tasks:

- Server access
- Nightly update
- Data backup
- Program and server operating system upgrades
- Server hardware upgrades
- User account and session management
- Records deletion
- Report generation (including Allsites and aggregate reports)

No More Down Time

An off-site data backup system is in the process of being established at the Polk County Schools technology building. This backup system will provide a secure backup copy of the

CHRIS statewide master database that can be accessed by authorized users when the main site in Miami is down. In response to an extended power outage or hurricane warning, access to CHRIS will be transferred to this backup system providing virtually uninterrupted access to users throughout the State. The Polk County Schools technology building currently provides secure storage for public school records for the Florida Department of Education and, as such, represents an ideal location for the CHRIS database backup. Thank you to Polk County Schools for your collaboration and continued assistance in establishing this system.

After six months of stressful days and sleepless nights, our Project Manager/Programmer, Olga Camacho was able to produce the first *live* CHRIS Master Database. *Thank you Olga, the rest of the CHRIS Team, and all the CHRIS users for all your hard work and patience.*



Screening Final Result (SFR) and Referral for Evaluation (RE) Comparison for the 2002/2003, 2003/2004, and 2004/2005 Academic Years

Screening Final Result (SFR) counts were based on the number of records with an F (fail) or an A (at-risk) in the Screening Final Result field and a value in the Screening Final Result Date field. Referral for Evaluation (RE) counts were based on the number of records with a value in the Referral for Evaluation Date field. Using the SFR and RE date fields, results were grouped by academic year (July 1 through June 30) for the years indicated.

Note: Data for the 2002/2003 and 2003/2004 academic years were based on timelines created for conversion to CHRIS Plus. Converted timeline data may not be an accurate reflection of data entered directly into CHRIS Plus. 2004/2005 will be used as the baseline for all future timeline event reports.



Statewide Reports

The implementation of Citrix CHRIS *Plus* has greatly enhanced reporting capabilities. Reports using statewide data can be run on the live master database at anytime, providing immediate, up-to-date reports. The figure above illustrates one of the statewide reports that can be run in Citrix CHRIS *Plus*.

CHRIS RESEARCH PUBLISHED

A research study examining the early risk factors for speech and language impairments was published in a recent issue of the journal *Exceptionality*. This study utilized integrated data from both the CHRIS and State of Florida birth certificate records databases. Results indicated that factors such as multiple birth, presence of a newborn condition, presence of a congenital abnormality, maternal age older than 35 years, and presence of a maternal medical history factor were consistently associated with speech and/or language impairments in preschool-aged children. Differences in the factors that place chil-

dren at increased risk for speech versus language impairment were also identified. Most notably, prematurity and low birth weight increased risk for language but not speech impairment. The full article can be accessed from the CHRIS website www.chris.miami. edu – Publications - Research.
