After twenty years in Miami, at the Mailman Center for Child Development and the last fifteen or so years working on CHRIS and its predecessors, we decided it was the time to turn over CHRIS and our Mailman Center responsibilities to the next generation. In December 1998, I accepted a position with the Tennessee Department of Health as Director of Systems Applications and Operations in the Bureau of Information Resources. Three managers and forty staff members responsible for software development, technical services and mid-range systems report to me. We manage all Department of Health computer systems and software. My first project is to create a statewide registry of children with special health care needs. Does this sound familiar? The system will be called Children's Information Tennessee (CIT). All agencies providing case management services, vital records and the Statewide Immunization Information System will provide data to CIT. The key to the success of CIT is the creation of an unduplicated registry with links to each participating agency. The registry will provide the basis for studying interventions and outcomes for children in Tennessee without having to make personal identifiers available.

On the personal front, Terri finally made the permanent move to Nashville on March 3rd. We sold the house in Miami on the 4th, closed on the house in Nashville on the 5th and the movers arrived on the 8th. We are still living amidst 400 boxes, hoping to unpack our way back to normalcy. Terri got the house she has always wanted, 3000 sq. ft, lots of windows, 2 fireplaces, 2 stories, hardwood floors, on the crest of a hill with views of down town and the hills. We are 10 minutes, at rush hour, from my office in downtown Nashville. For the last 2 ½ months I have been living in my daughter's attic. It has been wonderful spending time each day with Emma. The experience has reinforced our decision to move here.

Technical Notes

Olga's CHRIS Tips

Reporter Reminders:

As you know, Reporter is part of your CHRIS99.01 program. It will enable you to create a variety of reports of your choosing. You are the captain of the ship and you can decide what you would like your report to include as well as how it should look. With the birth of the powerful Reporter there are a few things to keep in mind.

Reporter update must be run with FileMaker Server stopped and no users in CHRIS. This can be done as a morning or afternoon routine; whichever is more convenient for your site.

- 1 Please check that the time and date on your computers and server are correct.
- 2 If Reporter fails, please call us as soon as possible.
- Some functions of Reporter will not work if you have not been upgraded to FileMaker Pro 4.1. We distributed FileMaker Pro 4.1 at the CHRIS Power Days training to all the FDLRS Centers. Some issues have arisen around the installation of FileMaker Pro 4.1. If you have not yet installed your upgrade, please call the Help Desk for some precautionary suggestions. If you are experiencing any difficulty since installing, you should also call the Help Desk.

Other Reminders:

- It is essential for us to be able to access your computers. Please check periodically to make sure your modems and lines are in working order. This will eliminate delays to fix things when we need to dial in to provide technical support or to upgrade the program.
- Agency Update must also be run with FileMaker Server stopped and no users in CHRIS. You can, however, make all of the changes necessary to the agencies file with FileMaker Server started and other users using CHRIS. Once all the changes have been made then ask users to exit CHRIS, stop FileMaker Server and run the Agency Update program.

A Letter from Our New *Project Director*

Greetings everyone!

As Rick pointed out in his "farewell" letter, in addition to CHRIS moving from the Mailman Center to the Department of Psychology, one of the changes was that I became the Project Director. So, let me briefly introduce myself. I joined the faculty at the University of Miami, Department of Psychology in the fall of 1994. During the last five years, I have been involved on projects that were supported by FDLRS. For example, I adapted and translated a screening test developed by Dr. Marcia S. Scott into Chinese. With Rick and Dr. Keith Scott, I have been working on linking several large state databases such as the Florida birth and school records. The goal is to identify early childhood risk factors with long-term impact

on school performance. One of my objectives is to integrate the CHRIS data into this database, as a means of obtaining further insight into such risk factors.

In the three short months since I came on board I have been extremely impressed by the depth and complexity of the project, as well as the CHRIS software program itself. It is indeed a challenging task to identify children in the State of Florida with potential learning and developmental disabilities, and to provide them with appropriate assistance. Of course, without the effort of everyone at the FDLRS sites and the hard work of the CHRIS staff, none of this is possible. I have to say that I am very fortunate to have Annie Hymowitz Garber and Olga Camacho on the CHRIS team. Along with Rachael Spanjer, they have made my transition to the project as smooth as possible. I would like to express my sincere thanks to all three of them.

Speaking of the CHRIS team, I am sorry to report that Cristina Rojas has left the project in pursuit of other opportunities. We wish her the best. However, we do have a new addition to the CHRIS staff, Maria Mora, who recently moved from New York to Miami. Maria will be responsible for receiving and directing all phone calls that come in to the help desk. In the meantime, we are in the process of hiring Cristina's replacement for the computer lead operator position. This will be the primary person to assist users with questions regarding the CHRIS program and FileMaker. In addition, with the move to the Department of Psychology, we now have Vivian Perez from FDLRS-UM assisting us in newsletter publishing and website designs. One of our goals is to expand the current CHRIS website so that CHRIS information can be directly accessed via the Internet.

Another benefit resulting from our move to the Department of Psychology is that we can take advantage of the department's computer lab facility in order to provide user training on a regular basis. The first session is set for May (please see page 5). More information on the training sessions will be made available soon, please stay tuned.

Finally, I would like to thank everyone at the FDLRS sites for your support to CHRIS in the past and hope you will continue to support us. I know there are times it is frustrating to deal with the program bugs and upgrades. But, as we all know, everyone is here for one mission: *To find that special child who needs our help*. As mentioned in Rick's letter, the State of Tennessee is now creating its own statewide registry of children with special needs. Also, about a month ago, I received an inquiry from a colleague at the University of Maine who is in the process of starting a similar system for his state. This shows we are at least 10 years ahead of other states! Let us keep up the good work. Testimony from Martha

The CHRIS Power Days focused on the new CHRIS *Reporter*. In my opinion, the *Reporter* feature is the most exciting part of the new CHRIS 99.01 upgrade. I noticed at the training there was some concern of the time issue involved in running the reporter. I would like to share what we experienced. When we received this upgrade, I immediately trained our CHRIS data entry person to incorporate the *Reporter* update process into our daily backup process. The first time we ran the *Reporter* update, we wrote down the steps and timed the process to see how much longer it would take. From the first step, stopping FileMaker Server services, to the completion of the *Reporter* update, it took only **three minutes!** The key to the **speed** of completing this process is stopping FileMaker Server services before you begin. We know this from experience, because the very next time we ran the *Reporter* update, we **forgot** to stop FileMaker Server. The process took **thirty-five minutes!** Thank goodness, no data was lost or corrupted. We learned a valuable

lesson-in fact, we learned several:

- 2. It is imperative that FileMaker Server services be stopped in order to achieve this speed!
- 3. Incorporating *Reporter* updates into the daily backup process is easily accomplished, doesn't add much time, and gives the immense satisfaction of having current data, daily, from which to create and run reports.

User Tips! What happened to me!

I was in *Find Events* and did a search for all the Referral events. FileMaker Pro found all the *Referral* events and all the Referral Out events because they both begin with the word "referral". My result in Find Events was almost double the number of records it should have been because we enter Referral Out events, also. In order to avoid this. I use the new Event Find option available in CHRIS 99.01. From the Tracking Summary Screen I go into a detail event of a Referral event. I select from the Menu Line "Find" and then enter a query on date or any of the other fields available in the Referral event. The result is all the records in my Query, but for Referral event only. I can then view my results in list view.

Strategies for Future Upgrades

We are exploring the options of changing the FDLRS Centers to export and import the CHRIS data so that it is not necessary to transfer all of the files with data each time there is an upgrade. This should cut the center's downtime significantly during upgrade. Transferring the data to the help desk has been necessary in the past because of scripts that had to be run during upgrades to change data to new terminology, or move data from one place to another in the database. In future upgrades, we would like to start testing transferring empty upgraded CHRIS files to the centers that they will be able to transfer their data into. Any complex part will be automated. Join the TAWG Advisory Board

What is the TAWG Advisory Board?

TAWG is the CHRIS Technical Assistance Work Group. Two years ago, TAWG was expanded to include an advisory board that joins the work group for two meetings a year. The purpose of the advisory board is to review decisions made by TAWG, help determine future direction of the CHRIS project and provide other input as desired. Regular workgroup meetings are held every other month. The regular workgroup receives input from CHRIS users and provides guidance on an ongoing basis to the CHRIS staff.
