CHRIS Data Shines

The School Board of Broward County has embraced the Sterling Quality Criteria. Florida businesses, agencies and school systems use Sterling to measure quality operations. One of the essential elements is Information and Analysis, which examines an organization's performance measurement system and how the organization analyzes performance data and information. Questions addressed are: what data will need to be tracked to confirm the accomplishment of the goals established for this issue/process, are the necessary systems in place to track these data, and when will these data be analyzed to determine the status of the goals and objectives for this issue or process?

The growth and demographics of Broward County continue to increase at a tremendous rate. FDLRS/REACH was asked to support the request for additional staff for a preschool assessment team. The Children's Registry and Information System (CHRIS) data set was the perfect tool to assist in this effort. Data compiled over a 5 year period indicated increases in the following: (1) the number of new referrals, (2) the number of children transitioning from Part C to Part B services, and (3) the number of children screened and referred to

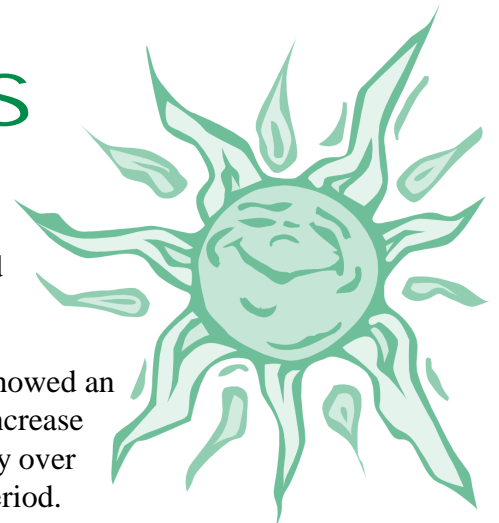
preschool and area staff for evaluations and staffings.

The numbers showed an almost 100% increase in each category over the five-year period.

This information along with other supportive documentation was shared with area and district staff, board members and the superintendent. As a result, funding was approved for a 4th preschool assessment team, consisting of an ESE educator, a speech/language pathologist, a psychologist and an audiologist. The impact of the 4th team has significantly improved the transition process, moving the district closer to its goal of a seamless system from Part C to Part B services. Additionally, the wait time for screenings has been drastically reduced and children previously on hold for evaluations are now being scheduled without delay.

The data gathered to support the district's need for personnel is a "sterling" example of the effectiveness of the CHRIS project as a tracking tool. The CHRIS database will continue to be used to plan, manage and evaluate future directions for FDLRS Child Find and to support district preschool initiatives for students with disabilities.

Greetings from Christine, the New Project Director

As you may have heard, or read on page 2, Dr. Shihfen Tu has taken a faculty position at the University of Maine. I was fortunate enough to replace her as the Project Director of CHRIS and would like to introduce myself. I have been involved in research at the University of Miami for the past 7 years. My research interests have focused on the development of communication in infants, particularly the relationship of early eye contact and gestures with later language and social skills. The ultimate goal of this research is to develop assessment instruments that will enable the earlier identification of children at-risk for autism and other developmental delays.



I am very impressed by the amount of effort it takes to identify and assist children with disabilities and hope that CHRIS continues to be an integral tool in serving these special children. To that end, I plan to work with the rest of the CHRIS team to improve the program to best meet the needs of all CHRIS users. In addition, I plan to utilize the data collected to examine the impact of early identification on school performance and the regional and demographic differences in prevalence rates of disabilities.
