SERVICE COORDINATION:

THE NEXT LEVEL

IDEA Reauthorization. Regional Policy Councils. OSEP Monitoring. Readiness Partnership Boards. Transition. Pre-K Evaluation and Assessment. K-20 Department of Education System. What are the implications of these all too familiar initiatives on the way we think about service coordination and preschool tracking systems in the world of Child Find? More screening referrals? Probably. Better coordination of information with other agencies and programs? Hopefully. Additional follow-up needed? Most assuredly.

The CHRIS Advisory Board and Technical Assistance Work Group have worked very hard over the last several months to ensure that the redesign of the CHRIS software program will provide improved means within the data system to make the gathering and use of service coordination information easier and more effective.

The redesigned CHRIS software program will have a transition event where all of the important required transition activities can be documented and made available for not only service planning but also program monitoring. Another feature of the system will be increased flexibility in the way local users choose to record service history and contact information.



In addition, the redesigned CHRIS software will provide better definition of the sequence of events and timelines as children move from referral for services to determination of eligibility for services under IDEA, Part B. This information will help identify systemic weaknesses that result in gaps in services to children. New features will encourage the use of action needed reminders so

children who are receiving services and have a temporary inactive service coordination status will not be overlooked when they reach a new milestone. Additional service coordination will be provided for such activities as transition from Part C to Part B programs or from pre-kindergarten to kindergarten programs.

A review of current records in CHRIS reveals there are still many districts where there is an obvious lack of information on the number of potentially eligible children with disabilities under age three in the system (see related table on page 4). The redesigned CHRIS software program will make the documentation of service coordination easier and the reliability of planning information better.
